RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely PADMASHRI AJIT WADEKAR COLLEGE OF PHYSICAL EDUCATION, SAI PRABHU APARTMENT, RAVINAGAR, CHOWK, RAMNAGAR, NAGPUR-440010, MAHARASHTRA vide Order No.WRC/2-32/124025/74/2005/5080 dated 27.06.2005 for B.P.Ed. course of one year duration with an annual intake of 50 students for the academic session 2005-2006.

AND, WHEREAS, the revised recognition Order was issued to the institution namely PADMASHRI AJIT WADEKAR COLLEGE OF PHYSICAL EDUCATION, SAI PRABHU APARTMENT, RAVINAGAR, CHOWK, RAMNAGAR, NAGPUR-440010, MAHARASHTRA vide order No. WRC/APW00696/124025/2015/147150-157 dt. 31.05.2015 for B.P.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-16 with following conditions:-

- The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- ➤ The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

AND WHEREAS, the institution has not complied with the conditions of revised recognition order. The matter was considered by WRC in its 255th meeting and Committee decided to issue Show Cause Notice u/s 17 of NCTE Act 1993 on the following points:-

Staff Profile for the session 2015-16 duly approved by the affiliating body.

Originally notarized Change of land Use/Non-Encumbrance Certificate, Building Plan and Building Completion Certificate.

AND WHEREAS as per decision of WRC Show Cause Notice was issued to the institution on 11.08.2016.

AND WHEREAS, the institution has submitted reply of Show Cause Notice dt. 02.09.2016. The matter was considered by the WRC in its 292nd meeting held on 19-17, May 2018 and the Committee decided as under:-

"Consequent to the issue of Revised Recognition order, Show Cause Notice dated 11.08.2016 was issued for non-compliance.

The institution vide reply dated 02.09.2016 has submitted the staff profile of 1+7 faculty members, which is not as per Appendix-VII of NCTE Regulations, 2014. The staff profile is not approved by the Registrar.

FDRs for additional Rs.7.00 lakhs in joint account and Building Completion Certificate issued by a Government Engineer not submitted in original.

Hence, Recognition is withdrawn from the next academic session 2018-2019."

AND WHEREAS, withdrawal order was issued to the institution on 02.06.2018. The institution has filed an appeal against the withdrawal order dt. 02.06.2018 and the appeal Committee passed an order dt. 12.09.2018 thereby remanding the matter to the WRC.

AND WHEREAS, the institution has submitted reply on 28.09.2018. The matter was considered by the WRC in its 299th meeting held on October 30 to November 1, 2018 and the Committee decided as under:-

"This is a case of Appeal. The Appellate Authority vide order dated 12.09.2018 has remanded the case to WRC for revisiting the matter, after the appellant institution submits required documents and taking further action expeditiously.

On perusal of the reply dated 28.09.2018 of the institution, the Committee observed that:-

- (i) The institution has submitted approved staff list of 1+8 faculty members. The institution is required to submit the duly approved original copy of the staff list as per Appendix-7 of NCTE Regulations, 2014.
- (ii) The built-up area as required under Appendix-7 of NCTE Regulations, 2014 for two courses i.e. B.P.Ed. and M.P.Ed. is not as per the norms.
- (iii) Building Completion Certificate duly signed by competent authority not submitted in original.
- (iv) FDR for Rs.12.00 lakhs as required under clause 10(1) of NCTE Regulations, 2014 not submitted.

Hence, the Committee decided that Show Cause Notice be issued to the institution. Reply should be submitted within one month, failing which recognition will be withdrawn u/s 17(1) of the NCTE Act, 1993."

AND WHEREAS, Show Cause Notice was issued to the institution on 14.11.2018. The institution has submitted reply of Show Cause Notice vide letter dt. 14.12.2018 & 28.05.2019. The matter was considered by the WRC in its 310th meeting held on 19-21, August 2019 and the Committee decided as under:-

"The Show Cause Notice was issued to the institution vide letter dated 14/11/2018 and reply received on 14/12/2018 & 28/05/2019.

On perusal of the reply of the institution, the committee observed that the institution has submitted a document as per the details of the documents required in Show Cause Notice dated 14/11/2018.

Hence, the committee decided to restore the recognition of one basic unit of B.P.Ed. programme."

NOW, THEREFORE, the Western Regional Committee hereby restore recognition of PADMASHRI AJIT WADEKAR COLLEGE OF PHYSICAL EDUCATION, SAI PRABHU APARTMENT, RAVINAGAR, CHOWK, RAMNAGAR, NAGPUR-440010, MAHARASHTRA for B.P.Ed course of one basic unit.

Further, if the institution is not satisfied with the Order, it may prefer an Appeal u/s 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this Order. The guidelines for filing appeal may be seen on NCTE's website.
